The UDF today moved a resolution in the House against the Speaker in the wake of allegations against him in the dollar smuggling case and over the alleged extravagance in the various construction activities carried out in the Assembly complex.

At the fag end of the four-hour-long discussion, Sreeramakrishnan was explaining his stand, Leader of Opposition Ramesh Chennithala rose from his seat and announced that since the Speaker was not budging to the demand, the opposition had decided to walkout. Indian Union Muslim League MLAM Ummer presented the resolution and citing the news reports, said "it seems like after the end of the current session of the Assembly, the customs may question Speaker"."When the Speaker of the Assembly needs to present himself before the Customs for questioning, it will affect the dignity of this House.
