Drop plan to raze, rebuild Duraisamy market: Vendors

THE Tambaram Corporation is planning to demolish the Duraisamy Market on Shanmugam Road and rebuild it with parking facilities.

"There are no parking facilities available in the locality leading to an increase in street parking. Some of the traders at the market are also stressed and because of that we are re-designing it," said an official.

However, the shop owners inside the market are worried their livelihood will be affected and only want the damaged shops repaired. There are meat shops, vegetable shops, and shops provided for Burma refugees among others.

only shops that are damaged, but are opposed to the reconstruction of the entire market," said a vendor. While the vendors claimed that there are more than 1,000 shops, including those on the footpath, the corporation is planning to build only around 350 shops on the 4.5-acre land.

Vendors said only now they are recovering from the pandemic-induced losses and the project would set them back further. "It is not clear how long the construction will take. We don't know how to run our businesses till then. We paid rent properly even during the lockdown. Considering all of these factors, the corporation must reconsider the plan," said another vendor.

Meanwhile, the corporation officials said talks will be held with the vendors before they proceed with the plan.

HIT BY SHORTAGE, IDOL MAKERS REMAIN IDLE

AHEAD of the Vinayakar Chaturthi on August 31, which is celebrated with pomp and gaiety in the State, the idol makers are busy with last-minute orders. However, a few said they were not able to make as many idols as they would like this year due to hassles in obtaining clay sand and manpower shortage.

A 55-year-old woman potter, Karpagam of Injambakkam on the outskirts of the city, told TNIE that pottery is a traditional handicraft which has contributed significantly to the economy. But, now the industry is in a poor condition.

Just a few years ago, many were involved in making idols, pots, and other things, but now due to a shortage in

raw materials and other factors, many left the field. I also stopped making idols due to a lack of space and manpower. Now, I only sell idols and other items, said Karpagam, who is worried that poor income would keep the next generation of idol makers away.

Another potter, Bhuvanewari (50) of Royapettah, said though she was getting clay sand, each bullock cart load which once cost ₹500 is now ₹6,500. "We are taking clay from Periyapalayam Arani on the city outskirts. Due to heavy traffic, we can't utilise the bullock cart and are forced to pay for transportation. The clay is of poor quality despite

being costly. As a result, the output is not good," she said. There were plans to procure clay from other districts, but

the plan had to be dropped due to high transportation charges.

Bhuvanewari further said, earlier there were over five persons working at her unit and she paid them between ₹300 to ₹500 per day, but now she is unable to employ anyone due to her poor income. Many potters have taken up other jobs like tailoring, watchmen, construction work, etc.

She requested the State government to help create job opportunities for the potters.

Arunachal kickboxer succumbs to injuries at hosp

A 24-year-old kickboxer from Arunachal Pradesh, who suffered a severe blow to his head during a bout at the Senior National Kickboxing Championship in Nehru Indoor Stadium on August 21, died at the Rajiv Gandhi Government General Hospital (RGGGH) on Tuesday. The deceased was identified as Yora Tade. Tade suffered



a hard blow on his head while trying to evade a punch from his opponent Kesav Mude (21) of Maharashtra and collapsed. He was given first aid and rushed to a private hospital. Later, he was shifted to the Rajiv Gandhi Government General Hospital, where a team of doctors performed surgery on him. He was admitted to the ICU and was monitored by a team of doctors.

Suresh Babu, chairman of the Kickboxing Association in Kolathur, has filed a police complaint at the Periamet police station.

Meanwhile, Tamil Nadu State Sports Minister Siva V Meyyanathan and other officials paid homage to Tade at the RGGGH. Later, the body was handed over to Tade's family members on Wednesday.

Royal Enfield doubles exports, all eyes on newly-launched Hunter 350

Chennai: Royal Enfield on Wednesday launched the new Hunter 350 in Tamil Nadu, a stylish light and compact motorcycle focusing on the crowded urban landscape. Speaking to TNIE, Yadvinder Singh Guleria, Chief Commercial Officer, said the shorter wheelbase, compact geometry and lighter weight make it manoeuvrable within the urban areas, adding this model will bring in a whole new set of consumers. the automobile industry is yet to reach the pre-pandemic levels. Royal Enfield is witnessing month-on-month improvement, he said. "We are selling around 55,000 units in a month compared to 2019 levels of 70,000 units a month. However, the export figures of the company almost doubled since 2019. 2 history-sheeters hacked to death, four held in Kanchi

FOUR people were arrested for allegedly murdering two history-sheeters near in Kancheepuram district on Tuesday.

According to the police, the arrested accused were identified as Vigneshwaran (22), Logeshwaran (19), Dilli Babu (21), and Pushaparaaj (19). On Tuesday night, Sujan alias Suren-dran (20) and Vicky alias Vignesh (23) were hacked to death by a gang close to the Manimangalam police station. The group fled after the attack. On information, the police reached the spot and rushed

the duo to Chromepet Government Hospital where they died.

Preliminary investigations revealed that the deceased duo had been arrested in March for the murder of history-sheeter Devendran. Four people including Suren-dran and Vignesh were arrested. The gang came out on bail last month.

The police said the four accused were friends of Devendran. They murdered Suren-dran and Vignesh in retaliation for their role in the murder of Devendran in March. Further investigation is on.
