ORDER

An application under Section 13(4) of the Companies Act, 2013 (hereinafter referred to as "the Act") was filed through e-Form No.INC-23 bearing SRN No. R56099039 by M/s Salem Erode Investments Limited (hereinafter referred to as "the applicant company") for confirmation of the alteration of Clause – II of the Memorandum of Association of the applicant company for shifting of its registered office from the State of West Bengal to the State of Tamil Nadu under the jurisdiction of ROC-Chennai as approved by members by Special Resolution passed in accordance with Section 114 of the Act, 2013 at its Extra Ordinary General Meeting held on 07.08.2020.

2. As per sub-sections (4) and (5) of Section 13 of the Companies Act, 2013 read with the Notification No. GSR 955(E) dated 27th July, 2017 of Ministry of Corporate Affairs, the Companies are required to file application under the provision of section 13(4) of the Act before the Regional Director for shifting of its registered office from one State to another. In pursuance of this, the above case has been filed and placed before the Regional Director, Eastern Region, Kolkata for disposal.



- 3. During the course of processing of the subject application, this Directorate has received objection/observation from M/s Amrex Marketing Private Limited represented by its director Shri Arvind Parasramka against the proposed Shifting of Registered office of the Company and accordingly to dispose the matter in order, several hearings were held on 19/10/2020, 02/12/2020, 22/12/2020, 25/01/2021 and 11/02/2021 wherein both, the Applicant Company represented by its Authorized Representative Md. Shahnawaz, Practicing Company Secretary and the Complainant duly represented by its director, Shri Arvind Parasramka were appeared and made their submission in the matter. However, subsequently by a letter dated 15/03/2021, the complainant M/s Amrex Marketing Private Limited under signature of Shri Arvind Parasramka, Director, communicated that they have withdrawn their objections filed vide letter no. AMPL-SEL-RD-08 dated 28/12/2020 and related letters and rejoinders filed before the Hon'ble Regional Director and also stated that they have no objection to the matter of Shifting of the registered office of M/s Salem Erode Investments Limited from the State of West Bengal to the State of Tamil Nadu. Further, by another letter dated 15/03/2021 addressed to the SEBI and the BSE Ltd with a copy forwarded to this Directorate together with many others including Registrar of Companies, West Bengal, Applicant Company (Salem Erode Investments Limited), the complainant stated that they withdraw their complaint filed vide letter No. AMPL-SEL-SP-06 dated 14/11/2018 and letter No. AMPL-SAT-02 dated 11/09/2020 and related letters and rejoinders filed before the SEBI and Stock Exchanges. The Reserve Bank of India vide its communication through email dated 18/12/2020 referring therein this Directorate's letter no. 4386 dated 07/12/2020. along with letter No. 321/02.02.302/2020-21 dated 18/12/2020 submitted that they have no objection for such shifting of registered office of Salem Erode Investments Limited. It is further observed that the Hon'ble NCLT, Kolkata Bench vide its order dated 29/09/2020 in C.A. No. 822/KB/2020 in CP No. 1824/KB/2019 made it clear that in spite of shifting of Registered office of the Company from Kolkata to Chennai or any other place, cause of action has already arisen here i.e. at Kolkata and therefore, the jurisdiction of this Bench shall not feter away.
- 4. Taking into consideration the contents of the application and affidavits filed in support thereof and submissions of the Registrar of Companies, West Bengal vide his report dated 28/09/2020 and other materials as available on record, it appears that the company has



complied with provisions of Rule 30 of the Companies (Incorporation) Rules, 2014 as amended time to time.

- 4. NOW THEREFORE, in exercise of the powers delegated on the undersigned under section 13(4) of the Companies Act, 2013 r/w Government of India, Ministry of Corporate Affairs' Notification No. S.O. 4090 (E) dated 19.12.2016, I hereby order that the alteration in clause II of the Memorandum of Association of the M/s. Salem Erode Investments Limited for shifting of Registered office from the State of West Bengal to State of Tamil Nadu under the jurisdiction of ROC, Chennai is confirmed subject to the following condition;-
 - (a) Payment of Rs.75,000/- (Rupees Seventy five thousand) only as cost in terms of Rule 30(9) of the Companies (Incorporation) Second Amendment Rules 2017.
 - (b) No employee shall be retrenched as a consequence of shifting of the registered office of the company.
 - (c) There will be no jurisdictional change in the legal proceedings pending if any, against the company on the date of this order.
- 5. The Registrar of Companies, West Bengal is directed to ensure that costs so imposed is deposited before taking on record order passed by Regional Director Eastern Region, in the matter.
